#### Insurance -

- It's important that you have an insurance broker that represents multi-companies to get a better understanding of your rate vs. only one rate.
- The group commented on these insurance companies,
  - o Citizens were considered the best overall.
  - Kinsale
  - Integrity
  - o Unique
  - Great FL
  - American Tradition (stay away from these guys)

#### **Eviction Process –**

- What do your documents say about evictions?
- What FL Chapter are you operating under and what does that chapter say about evictions?
- Get your attorney involved.
- Is the person going to harm him/herself or another resident, you may need to get the sheriff involved.

#### **Donations** –

- One community has a donor who wants to donate a large sum of money to the community, but the community does not want to take the responsibility of distributing the money within the community, they would prefer to let the donor do his/her own distribution.
- Suggestion was to get the communities Attorney involved in the distribution process.

## Restoring Mobile Homes -

- Becomes very permit conscious, you must meet all the permitting requirements for your community, city, county, and state.
- Many counties have permit requirements on their websites.
- Start with your county permit office, they have printed instructions on "how to" and "what to do" followed by your city.
- Do not depend on your "new" home supplier to do the permitting for you, they may not get all the permits required to restore or replace a unit.
- Remember you need a Demo Permit in order to demolish your home, some may require concrete to be removed too.

So many of the topics discussed fell back on what the community documents & FL Chapter they operate under say about the topic. If you follow your documents and your results are not favorable, you need to get your attorney involved to make them favorable or explain to you why not.
